

## Planning the Play in 1NT, the Toughest Contract in Bridge

Whatever the final contract, be it one notrump or any notrump, declarer makes the same preliminary plans for the play – don't play to trick one without developing a plan. Don't worry, it often changes.

- a. Review the bidding for clues, although opponents rarely have bid if in 1NT.
- b. Analyze the lead for clues about that particular suit how many do they have/honors/etc.?
- c. Count the sure tricks without losing the lead (KQJ10 is not a sure trick!)
- d. Where is declarer's best opportunity to develop more tricks?
- e. What is declarer's stopper situation in their suit, if the lead is lost?
- f. Develop a plan for each separate suit.

g. Develop a plan for the whole hand, giving careful consideration to the entries and timing.

The reason 1NT is the toughest contract is that there are typically lots of leading back and forth between dummy and declarer's hand. Rarely is it obvious where the seven tricks will come from, because they often come from many suits, not just one or two suits. Entries and timing the order of suits played are often the keys to success.

Possible winners are potential tricks that may or may not be realized, since they depend on 1) driving out the opponents' higher card(s) to promote lower cards, 2) taking finesses, 3) ducking to give the defenders their trick(s) early to keep an entry to additional tricks, and 4) how the missing cards in a suit might divide.

The normal strategy for playing a notrump contract is to work on the possible winners early in the hand, while the stoppers are still intact. Plan to cash the fast winners later in the hand, when the stoppers have been removed or there are enough tricks to succeed.

When declarer does NOT need the long suit for entries, often it is best to run the



long suit to force the defenders to discard. Beware doing this without length so winners won't be developed for defenders if they have more length than declarer's length.

All the while declarer is building up tricks, the opponents are looking for ways to beat the contract. There are two common threats:

- 1. They might establish their long suit winners.
- 2. The "wrong" opponent (called the "danger hand") might gain the lead and make a damaging lead through a vulnerable suit

### When should defender win a trick, when should defender duck



Winning with Wimpy By Jim Diebel

I've recently noticed with a couple of my students that they don't fully understand a card combination which arises fairly frequently.

The combination I am referring to is when dummy hits with KQTxx(x) and they are sitting behind the dummy with the ace.

At some point in the hand, the declarer leads low toward the dummy in that suit, and plays the King or Queen.

Invariably, my students win the ace, as they've been taught to win tricks in 4th seat when possible. While it's true that winning tricks is generally a good thing, in this particular case it is almost always right to duck.

If that seems strange to you, then you definitely need to read this month's column.

First, we need a quick discussion about the hold-up play. Most players are familiar with the concept of holding up an ace until declarer is out of that suit.

The hold-up is critical to cut declarer off from extra tricks in dummy. It is less effective when dummy has a side entry, but can be instrumental in disrupting the delicate communication between declarer and dummy.

In order to win the ace at the most advantageous time, the defenders are schooled in giving count in those critical suits.

Now here's something you might not know: When defender holds the key card in a critical suit, that defender should always give false count to partner. The partner without the key card must absolutely give the true count.

Consider this hand: South opens 1NT and North raises to 3NT:

Dummy has no outside entries. At some point, South leads the \*Q. For the defense to have any chance, East must hold up, even though South could now drop his bare King. West, who does not hold the critical card, gives the true count: \*2 in the 1st example, and the \*8 in the second. If you are playing UDCA, reverse the plays.

Now consider this similar situation:

This time, when the \*Q is led, West holds the critical card and plays the \*8. East gives true count with the \*6 or the \*4. In all four cases, Declarer can't be certain whether to try to drop a singleton King on his right, or play for the finesse.

If West was the type of player who always gave the right count, Declarer could get it right frequently. Declarer can't be certain whether West is giving the true count because he doesn't hold the

King, or the false count because he does.

Of course if East held &Kxx in any of these examples, the first duck would be elementary, and the contract would always fail. The Defense must give Declarer a losing option.

Now we turn to the combination that so many get wrong. Dummy can be assumed to hold a side entry:

When Declarer leads toward the Clubs, West plays the true \$2 (UDCA \$9), because he doesn't hold the ace.

East must smoothly duck. If East makes the mistake of winning the trick, Declare will finesse the \$10 the next time he plays the suit. By ducking, the defense gives declarer a losing option.

This time, West does hold the critical card, and gives false count (\$9, UDCA \$2), again the \$K will win the first time.

The next time Declarer leads toward the combination, West must smoothly duck again, and declarer will often misguess by putting in the \$10. Note that in all four cases, the defense was only

entitled to one trick if Declarer plays the suit optimally.



If there is a side entry, and it is a suit contract (some other suit), West should not duck the A on the second play, because declarer can now establish the suit with a ruff.

Assume you are East, defending a NT contract and you encounter this layout:

When the suit is led, West gives the true count. North plays the \*K. It may appear safe to win the \*A.

Once again, this is the wrong play. Even if dummy has no outside entry, East has surrendered control of this key suit.

Although East is entitled to two tricks in the suit. when he gets them is essential to the success of the defense.

Note that in the 1st example, if Declarer has a side entry, he can duck the second round of the suit, guaranteeing three tricks from the combination.

In the second example, declarer finesses the \$10, once again getting his three tricks.

If East ducks the first round, he can hold Declarer to one trick in the suit if there is no outside entry.

If he can win the second round and successfully remove dummy's side entry, he can shut out the suit altogether.

I, sitting North, got off to the terrible lead of a low spade.

A heart lead would have been much better. Declarer won the \$10 and led a diamond, 6, Q,

A. South continued North's ill-conceived attack with another spade. Declarer won in dummy, overtook the ♠K getting the unwelcome news that trumps weren't 3-3. Declarer now successfully passed the ♠T.

When this held, declarer drew the last trump, and ran the diamonds, getting nine tricks total. This was a well-deserved top for EW and a more than well-deserved bottom for NS.

While it's difficult to lay this disaster at the feet of my partner, had she ducked the

♦ A, I am confident my poor choice of opening leads would not have cost us the board.

I am a staunch advocate of "less is more." My observation is that at every level of the game, players are using too many conventions. Too often I see players (from beginner to world champion) misusing or forgetting their methods. Everyone would benefit if they would just KISS. (Keep It Simple, Stupid.) Don't spend all of your time learning new conventions instead of working on your play.

If I had to choose just four conventions, this would be my list:

A)

- 1. Negative Doubles
- 2. Blackwood
- 3. Stayman
- 4. Jacoby transfers

If you forced me to choose four more, this would be the next group:

B)

- 5. 4th Suit GF
- 6. Methods (I prefer "DONT") vs. Opponents' Notrump
- 7. Weak jumps in competition
- 8. 2NT ask (Feature) after our Weak 2-bids

If you insisted I fill my convention card with 12 conventions, these would be the next four:

C)

- 9. Unusual notrump / Michaels bids
- 10. New Minor Checkback
- 11. Jacoby 2NT
- 12. Support Doubles

And, since people just love to learn/play/teach conventions, these would be my D-list -- choices 13-16:

D)

- 13. Lebensohl
- 14. Drury
- 15. Inverted Minors
- 16. Splinter Bids

Honestly, I think it would be counterproductive for 99 percent of players to go any further than this. The memory strain is not worth it. Someone once said, "The Road to Hell is Paved with Good Conventions."

# Fifth Chair



#### 21 Rules of Being a Good Partner

By Marty Bergen

- "I have always believed that your attitude toward your partner is as important as your technical skill at the game." Rixi Markus, one of the all-time great players. Before you sit down to discuss what you are playing, you should start your partnership off on the right note. Half the battle of winning is being a good partner. Always observe the following:
- 1. Do not give lessons, unless you are being paid to do so. "According to an evening paper, there are only five real authorities on bridge in this country. Odd how often one gets one of them as a partner." *Punch* (British magazine).
- 2. Never say anything to your partner unless you would want him to say the same to you. If you are unsure whether your partner would want you to say something, don't.
- .3. Never "result" (criticize your partner for a normal action just because it did not work this time).
- 4. Unless your intent is to clear up a misunderstanding, avoid discussing the hand just played. If you cannot resist, be discreet.
- 5. Remember -- you and your partner are on the same side.
- 6. Do not forget that your partner wants to win as much as you do.
- 7. If you feel the urge to be nasty, sarcastic, critical or loud, excuse yourself and take a walk.
- 8. When there is time between hands, do not discuss bridge.
- 9. When you want to consult another player about a disaster, ask about your hand, not your partner's.
- 10. Do not ever criticize or embarrass your partner in front of others.
- 11. Remember that bridge is only a card game.
- 12. Have a good time, and make sure that your partner does also. "Bridge is for fun. You should play the game for no other reason. You should not play bridge to make money, to show how smart you are, or show how stupid your partner is... or to prove any of the several hundred other things bridge players are so often trying to prove. " Bridge legend Charles Goren.

- 13. Trust your partner; do not assume he has made a mistake.
- 14. Although it may be unfashionable, it really is okay to be pleasant to a partner with whom you also happen to live.
- 15. Remember: "The worst analysts and the biggest talkers are often one and the same. "Bridge columnist Frank Stewart. Think twice before verbally analyzing a hand. Do not embarrass yourself with a hasty, inaccurate comment.
- 16. When you voluntarily choose to play bridge with someone, it is not fair to get upset when partner does not play any better than usual.
- 17. Never side with an opponent against your partner. If you cannot support your partner, say nothing.

18. If you think you are too good for a partner, and do



enjoy

playing bridge with him, do everyone a favor and play with someone else. That is clearly much better than being a martyr. However, be careful before burning bridges -- another player's grass may not be greener.

- 19. Learn your partner's style, regardless of how you feel about it. Do not expect your partner to bid exactly as you would. When partner makes a bid, consider what he will have, not what you would have.
- 20. Try to picture problems from partner's point of view. Seek the bid or play that will make his life easiest.
- 21. Sympathize with partner if he makes a mistake. Let your partner know that you like him, and always root for him 100%.

Players must reside in District 13. Each member of the team must be a paid member in good standing with the ACBL.

Club qualifying games are permitted at Unit discretion but are not required at any level of competition. A Flight B or C team may qualify under the rules of any Unit where a plurality of team members reside.

Players who are current, or have ever been members of another bridge organization - domestic or foreign- must submit information on their past and/or current ranking in that organization.

An entry in the Championship Flight is a commitment to play in the National Final. Any teams representing District 13 at the National Event will receive a stipend paid at the NABC.
