The event, which is held during the WinterFest Sectional, will take place at the Countryside Church Unitarian Universalist in Palatine.

Awards include the Mini-McKenney, which recognizes the players who won the most masterpoints in their category during the year. The Ace of Clubs recognizes the players in each category who won the most points at club games during the year. During the meeting, five people will be elected to three-year terms on the 15-member board. Bill Anspach, Phyllis Bartlett and Loring Knoblauch have been re-slated and will be joined by Steve Donahue and Kathy Fortney. Sarik Goyal and Joe Stokes opted not to run.

A recent Monday started out well for frequent bridge partners Mike Devine and George Roeper, and their longtime friend and carpooler Marge Hedegard.

All three, with different partners, had scratched in the Royal STaC at the Calumet Club. But unknown to them then, their biggest win would come after the game.

Mike pulled into a nearby station for gasoline. When he reentered the car, he said, "I don't feel well." He resumed the drive, but immediately pulled over, stopped the car and said, "I've never felt like this before."

Although there was a hospital nearby, George followed the experts' advice and immediately contacted 911. Paramedics arrived within minutes.

Mike was in the Emergency Department within 20 minutes of the onset of his symptoms, well within the golden hour for someone experiencing a cardiac event.

Mike said he probably would have dismissed his symptoms and continued the drive if he hadn't been with his friends. Mike is a hero for speaking up and allowing his friends to help.

George and Marge are heroes for quickly recognizing something was not right and rapidly activating 911 and the emergency response.

#### Declarer needs to count both fast and slow tricks to be a winner



Winning with Wimpy By Jim Diebel

This month's column will not have a lot of new information for the experienced player, but if your declarer play could use some fine tuning, you may want to pay attention.

#### **Declaring at No Trump:**

When the opening lead is made and dummy comes down, Declarer needs to count his tricks. There are two types of tricks he needs to count: Fast Tricks: These are tricks that can be taken off the top. Slow Tricks: These are tricks that need to be developed.

An example of fast tricks: North: ♠ QJ83 South: ♠ AK72 There are 4 spade tricks available whenever declarer wants

Slow tricks may need more than one lead to develop: An example:

North: ♠ QT8 South: ♠ J74 Declarer can develop one spade trick if he's willing to give up the lead twice.

You need to run your Fast Tricks when the opponents have a long suit they plan to run, and you have no stopper.

When all side suits are safe, it's generally better to try to develop your Slow Tricks.

As a BBO director, here's a look at a few examples from a hand I witnessed on BBO recently.

North

- **♠** 7 3
- ♥KQJT5
- ♦ T 6
- ♣J953

South

- **♠** K 8
- ▼ A 3 ◆ A J 9 4 3
- **♣** A Q T 4

South West North East

1D P 1H P 2NT P 3NT All Pass

You are South in 3NT. The opening lead is the ♣4. East plays the ♣J and naturally, you win the king.

The opponents have at least 4 spades ready to run against you. Counting your fast tricks, you have 5 hearts, 1 spade, 1 club, and 1 diamond. That's 8 tricks, so you're going to need the club finesse. The good news is that you don't need to take it right away.

Best strategy is to run 5 hearts, pitching a diamond, your last spade, and finally another diamond. This may put a little pressure on West, who might pitch a spade or two in order to keep some minor suit honors. With any luck, West pitches at least one spade and you take the club finesse.

If it loses, you hope West can't cash more than 3 spades. You'll discard two diamonds and a club and cross your fingers West must give you the rest. I gave you the correct hand, but not the actual lead at the table.

What really happened is that West led a low diamond, and

declarer made a great play to go up with ♦10. When the lead is coming through dummy and dummy has Kx, Qx, Jx, or 10x, it is usually right to go up with dummy's honor. One notable exception is when dummy has Qx or Jx, and you hold Jxx or Qxx. In those two cases, you must play low to insure a trick in the suit. The same is true if dummy has Kx and you hold Jxx. You must play low from dummy. Give dummy Jx opposite your Kxx, and it's once again right to go up with the honor. I digress.

The \$10 won in dummy, and declarer did not stop to count his tricks, or to take inventory of his assets. Unlike the previous example, Declarer is in no immediate danger, so long as he doesn't lose a non spade trick to East.

East is the "Danger Hand," as a spade lead from East could be disastrous. Fortunately, you have an avoidance play available in clubs.

You can lead the ♣9 from dummy, and let it ride. Should West show up with the ♣ K, you still would have a positional spade stopper. Once you win the ♦10 at trick one, you should not do any worse than 5 hearts, 3 clubs, and two diamonds for 10 tricks. If West wins and makes the likely spade shift, you will make 11 tricks.

If he switches back to the ◆K, you can win and return the ◆J. Now if they DON'T immediately switch to a spade, you will still emerge with 11 tricks.

The Declarer I monitored played the hand as if the opening lead had been a spade. He ran his 5 heart tricks first, squeezing his own hand in the process.

What is he going to pitch on those 3 winning hearts? Certainly not a spade. He still had only 8 top tricks, cashing the hearts early forced him to part with either some of his club winners, or possible diamond winners.

Eventually he chose to pitch 2 clubs and 1 diamond. He now took a hopeless finesse of the •9 losing to the •Q, and when a spade came back to East's Ace, he managed to take 9 tricks.

West made a poor lead choice. Declarer had opened a diamond, but South did not take advantage. With the ♣K and ♠A sitting favorably, declarer could not take fewer than 12 tricks.

After winning the diamond, he runs the ♣9, eventually scoring 4 club tricks. Now he runs 5 hearts, and (knowing where the ◆KQ are), discards down to the ◆Kx and the ◆A.

A spade from dummy hands him his 12th trick. Taking 9 tricks gave South his well deserved bottom.

#### What does partner's unusual bids mean?

You find a partner you enjoy playing with and you play regularly and start to develop some basic understandings and working out a system you both enjoy playing. No matter how much time you spend, there will occasionally be bids that partner throws at you that haven't been discussed and are hard to decipher. Some days it seems almost every bid is like that. Give partner some room — usually you can work out what they mean . Here are examples of fairly common bids like that.

Answers:

- 1. North's 3♥ is natural, usually showing 6+ card ♥ and forcing. North should not introduce a new suit here, so what can 4♦ mean? It is called an advanced cuebid and says he likes ♥ and also has the ♦A, an example ♣ 74 ♥ KT3 ♦ A9 ♣ AKQT83. It suggests he thinks slam is possible, and implies he doesn't have a ♠ control, since the controls are shown up the line.
- 2. West's 2NT bid is the unusual NT, for takeout emphasizing the minors, usually 5-5. To bid 4NT, West might have a huge minor 2 suiter, thinking EW can make game, but more likely he thinks NS can make game and he is sacrificing. West might have
- A ♥ 3 ◆AQ9863 ♣ KJT832.
- 3. Your hand as South is ♠ KQ963 ♥ K6 ♦ QT863 ♣ A –. What do you bid? Partner should be showing a weak hand with long clubs, at least 6 or more ♣, and no support for either ♠ or ♦. Many players bid 3NT and my guess is that will be down 2 or more, often many more. With misfit hands it is best to pass as soon as the misfit is known, and try to avoid NT. South should pass!
- 4. Is West preempting over South's weak two? NO. Only one side can preempt. Jumps here are natural, long suit overcalls within 1 to 1.5 tricks of game. The overcaller needs little in support, just a trick or more.
- **♠** AKJT874 ♥ K3 ♦ QJT ♣ J.
- 5. If West has a Michaels cuebid and shows 5+♠, is North trying to show ♠? Since ♠ is the only suit NS knows that West holds, then that cue bid is a cue bid in support of South's ♥, showing a limit raise of ♥ or better, something like ♠ K4 ♥ KJ73 ♠ AJT ♣ 7643. It promises 3+♥ and 10+ support pts.
- 6. North's bid cannot logically show ♠ length since he didn't respond 1♠. The

2♠ here is called the impossible ♠ raise, showing the best possible raise of ♠ maximum high card points and long ♠, often 6+♠. The 2♠ is stronger than bidding 3♠, which is more of a courtesy raise. The 2♠ bid can be used over a 2♣ or 2♠ rebid by opener. It can be used playing 2/1 or standard.

#### Choose the play that gives opponents chance to make mistake

Here's a card play principle to keep in mind: When facing a choice between two seemingly equivalent lines of play, choose the one that gives the opponents an opportunity to make a mistake.

This recent deal is an illustration: North dealer, matchpoints

N-S vulnerable North A9764 Q87 J86 T3 West East 52 KJT8 92 T3 A973 KT52 J9864 K75 South O3 AKJ654 04 AQ2

After two passes, South opens 1H. With East-West staying silent, North raises to 2H and South carries on to 4H.

West leads the five of spades; dummy plays low and West wins the king, returning the jack of spades to South's queen. Now South plays the ace of hearts and a heart to dummy's queen, noting the 2-2 split, and then pitches a diamond on the ace of spades.

There are three things South would like to do: set up the long spades for a second diamond discard; take a club finesse; and ruff the third club in dummy.

If South could do all three of those

things, then South would take the rest

As such, while the defense has missed their opportunity to take two quick diamond tricks to hold declarer to four, it appears as though the defense is still destined to come to a second trick.

The most obvious line of play is for South to take the club hook at trick six. When it wins, declarer cashes the club ace and ruffs the club. Now declarer can establish the a spade winner by ruffing, but can't reach dummy to use it. As such, South is fated to lose a diamond in the end, making five.

But, look at what can happen if declarer instead decides to ruff a spade at trick six, then cross to dummy with a small heart at trick seven.

Declarer now leads the established spade from dummy in the following six -card position:

North 9 -- J86 T3 West East -- -- A97 KT5 J98 South -- KJ Q AQ2

After pitching the queen of diamonds on the spade, South still makes only 11 tricks on best defense, losing a club at the end. As such, on a double-dummy basis, this line of play neither gains nor loses anything over the normal line discussed above. Both lines make five when the club king is onside, and four when it is offside. However, here "best defense" means that at least one defender needs to hold on to all three of the clubs, and that defense may

be hard to find. South is known to have started with exactly five cards in the minors. The defenders may be reluctant to place declarer with a third club after South had eschewed the opportunity to take a club ruff.

At the table, East pitched a small club on the spade at trick eight. This was necessary if South had started with AQxx of diamonds, in which case a diamond pitch from KTx would make it possible for declarer to take three diamond tricks.

After declarer pitched the queen of diamonds on the spade, he took a successful club hook which was followed by two rounds of hearts. West needed to find a discard on trick 11 holding the bare ace of diamonds and the jack-nine of clubs. West decided that South was more likely to hold the king of diamonds than a third club, and thus pitched a club.

The club ace now got rid of the defense's remaining cards in that suit, and declarer's deuce of clubs was good on trick thirteen: making six, for a top.
